## ENROLLMENT DETAILS

Foreign citizens, stateless persons, and expatriates from far and near abroad are all eligible for studying at Russian universities. To apply for an education program at a Russian university, an applicant must confirm the completion of the required education stages analogous to high school or vocational school in Russia. Foreign citizens applying for the master's degree programs at Russian universities must provide their bachelor's degree or specialist degree certificate or another equivalent education certificate issued by a foreign university recognized in Russia.

International applicants are eligible for both **self-funded** and **state-funded** education (via federal funding), in accordance with:

Agreements and other international documents signed by the Russian Federation;

Quota of the Government of Russia (Order of the Government of the Russian Federation dated December 18, 2020 No. 2150);

Federal Law dated May 24, 1999, No. 99-FZ "On the State Policy of the Russian Federation concerning compatriots abroad."

## DOCUMENTS REQUIRED FOR ADMISSION

1. **Passport** (or other identification document) and copy of all its pages;
2. **Notarized translation** (in Russian) of your passport;
3. **Education certificate** with the supplement\* + validation of foreign studies and degrees if necessary\*\*;
4. **Notarized translation of your education certificate** and its supplement (in Russian);
5. **Photos** 3x4 (6 pcs.);
6. **Health statement.**

\* Education certificates issued abroad must be legalized in accordance with the requirements of the Russian government or supplied with an apostille (with the exception of cases where legalization and apostille are not necessary under applicable law of the Russian Federation and/or international agreements). You can check whether your certificate requires consular legalization or apostille at <http://nic.gov.ru/ru/proc/lega>.

\*\* Validation of foreign studies and degrees is obligatory in cases when the applicant's degree is not recognized as equivalent to completing the corresponding education stage in Russia. You can consult the National Accreditation Agency website to find information about relevant international agreements at <https://nic.gov.ru/ru/docs/foreign/confirmation>.

## PROCEDURES FOR OBTAINING AN INVITATION

The Migration Assistance Department helps international students obtain an invitation to enter Russia. The applicant should provide the following documents and information via email at 2215776@mail.ru:

1. Copy of the international passport (photo should be visible; passport information should be legible); the passport should be valid for **at least a year and a half** as of Russian visa issuance.
2. Information about one's city of birth, city of obtaining a visa, and home address.

An invitation to enter Russia for educational reasons is issued by a local office of the foreign affairs federal agencies on demand of the receiving educational institution. The invitation is issued online and is sent to the applicant's email. The foreign citizen should provide a concise printed version of their invitation when applying for a visa at the consular office or diplomatic mission of the Russian Federation. Please note the visa can be obtained only in the city specified in the invitation, both in the concise printed version and in the full e-version.

The issuance of the invitation takes **up to 30 days** since submitting a properly finalized application.

Upon receiving an invitation form, the foreign citizen should independently apply to the Foreign Affairs offices abroad for obtaining the 3-month single-entry visa.

Foreign citizens, admitted to the KubSAU on a state-funded quota of the Russian Ministry of Science and Higher Education, should apply for a student visa under the Ministry's visa directive.

## MIGRATION REGISTRATION

In compliance with the acting migration legislation laws, foreign citizens and stateless persons crossing the Russian border must obtain and fill in the **migration card**. The card should be completed by hand in Russian; the information should be legible, with no corrections. The foreign citizens coming to Russia to study should put **"STUDYING"** in the "Purpose of Entry" field. In case a purpose specified in the migration card contradicts the factual reason for stay, the student is to be subjected to the administrative sanctions, as defined by the Code of the Russian Federation on Administrative Offenses, article 18.8.

**Upon their arrival in Russia, the foreign citizen must undergo the migration registration at the place of temporary residence not later than 3 BUSINESS DAYS after crossing the border.** The initial migration registration is valid for **90 days**, in accordance with Article 5, Stipulation 1 of the Federal Law "Concerning the Legal Status of Foreign Citizens in the Russian Federation".

**STUDENTS RESIDING AT DORMITORIES:** You must consult the KubSAU Migration Assistance Department (Krasnodar, 13 Kalinina St., Zootechnics Faculty bld., office 317).

For migration registration, you need:

1. Identification document (passport), original and copy;
2. Migration card, original and copy;

Upon completing the migration registration, the international student gets a certified copy of their migration card and temporary residence document (tear-off part of the arrival notice). Original copies of the student's temporary residence document and migration card are kept at the university upon request.

**STUDENTS RESIDING IN RENTAL APARTMENTS:** Your landlord must obtain migration registration for the place of your temporary residence. Once registered at the place of your temporary residence, you should provide copies of your migration card and temporary residence document to the Migration Assistance Department.

**!!! 10 DAYS PRIOR TO TERMINATION OF YOUR TEMPORARY RESIDENCE PERIOD,** you must extend your migration registration.

Foreign citizens coming to Russia with the student visa should undergo migration registration before the visa expires and extend it when necessary. International students coming to Russia under the procedure requiring no visa should undergo migration registration that lasts until their graduation.

In case of **LOSING** or **DAMAGING** your documents (passport, migration card, temporary residence document), you must **immediately** inform the Migration Assistance Department and **independently** apply for reissuance of your documents.

In case of **EXPIRATION OF YOUR PASSPORT**, you must leave Russia preemptively or timely apply for its extension or reissuance at the consulate of your country and inform the Migration Assistance Department. Once you extend or reissue your passport, you must **immediately** present it to the Migration Assistance Department for the visa reissuance procedure (if necessary) and complete the migration registration.

**WHEN LEAVING RUSSIA**, you must fill in the form at the Migration Assistance Department and sign it at the Associate Dean of the International Affairs of your faculty and dormitory supervisor (if you are residing at a dormitory), attach the copy of your ticket and originals of your migration documents.

**WHEN LEAVING THE CITY OF KRASNODAR** for over 7 days, you must undergo the migration registration at the place of your residence. Next, you should provide the copy of your new registration document to the Migration Assistance Department. Once returned to Krasnodar, you must register again at the place of your actual residence.

**INTERNATIONAL STUDENTS MUST:**

- have on them the tear-off part of the arrival notice (temporary residence document) for the whole approved duration of their stay in Russia.
- present it with the passport and migration card copy to the law enforcement officers during their migration checks.

## MEDICAL CLEARANCE AND DACTYLOGRAPHY

All foreign students who arrived in Russia after 29.12.2021 based on the Federal Law No. 128 FZ “On the State Dactyloscopy Registration in the Russian Federation” must undergo a medical clearance, dactyloscopy registration, and photography. The duration of these procedures is under 90 days from the date of arrival in Russia.

The following sanctions are reserved in relation to individuals who have not undergone the established procedures or have done so with a delay: a fine and/or expulsion from Russia and an entry ban for up to 3 years.

They are exempt from need to undergo new procedures: citizens of the Republic of Belarus, family members of officials of international organization, as well as employees of diplomatic and consular institutions in Russia, foreign citizens with dual citizenship, one of which is Russian citizenship, foreign citizens holding temporary and permanent residence.

It is possible to undergo a medical clearance and dactylography at the following address: Krasnodar, 100/5 Dzerzhinsky St. (parking lot of the “Krasnaya Ploshchad” shopping center, “Multifunctional Migration Center”).

Working hours: 7.30 am - 5:00 pm, Monday to Friday, no breaks; no prior appointment needed. Days off: Saturday and Sunday.

You should bring:

- Passport (original), migration card (original);
- Registration (original), notarized passport translation (you are to keep your documents; the originals are necessary only for authorization).

## TEMPORARY RESIDENCE PERMIT FOR THE PURPOSE OF EDUCATION

As of January 1, 2023, the order of the Ministry of Internal Affairs of the Russian Federation dated December 14, 2022, No. 949, approved the Administrative Regulation for providing a state service for issuing **temporary residence permits for the purpose of education** to foreign citizens and stateless persons.

Students of Kuban State Agrarian University who are enrolled in full-time bachelor's, specialist, master's, and postgraduate studies have the right to obtain a temporary residence permit for the purpose of education. The document is issued for the entire duration of studies and for the subsequent 180 calendar days. It is formalized as a stamp in the identity document.

After completion of training, a graduate with a temporary residence permit for the purpose of education is eligible to apply for a residence permit in a simplified procedure within three years without the need to obtain a temporary residence permit in the Russian Federation.

For students from visa countries, it is necessary to provide a **certificate of clean criminal record** from the country of citizenship. The certificate must be issued not earlier than 3 months before the day of application submission to the Main Directorate of the Ministry of Internal Affairs of Russia in Krasnodar Territory. On the part of the university, the following documentation package is collected: characterization, attendance report, certified copy of the contract for dormitory, and certificate from the university.

The maximum term for the provision of a state service is 38 working days. The term is calculated from the date of registration of the application and documents required for the provision of the state service.

Students who have a temporary residence permit for the purpose of education are exempt from annual medical clearance and annual renewal of voluntary health insurance (VHI). They are eligible for obligatory health insurance (OHI).

You can contact 2215776@mail.ru or go directly to the Migration Assistant Department for more detailed advice on obtaining a temporary residence permit for the purpose of education.

## VISA EXTENSION

Upon entering the Russian Federation, international students should prolong their stay, regularly extending their multi-entry visa throughout the period of study in accordance with the education laws of the Russian Federation; please note that each visa is valid for a year.

To apply for the multi-entry student visa, you must provide the following documents to the Migration Assistance Department **no later than 40 DAYS prior to the expiration of your current visa**:

1. Passport and copy of all its pages containing information;
2. Copy of your migration card and temporary residence document (tear-off part of the arrival notice);
3. Copy of your education contract;
4. 1 photo, 3x4 cm;
5. Confirmation of payment of the state fee (state-issued services are charged with a state fee amounting to **1,920 RUB**. You can find the payment confirmation form at the Migration Assistance Department and pay in any bank).

**! Upon extending your multi-entry visa, you must apply documents to prolong your registration covering the validity period of the issued visa !**

## HEALTH INSURANCE

Voluntary health insurance (henceforth “VHI”) acquired with the foreign citizen’s personal funds warrants the provision of medical services over the period of their stay in the Russian Federation.

Chapter 5, Article 27 of the Federal Law dated 15.08.1996 No. 114-FZ “On the Procedure of Exiting and Entering the Russian Federation” stipulates that foreign citizens are barred from entering the Russian Federation in case they have not provided VHI valid on the territory of the Russian Federation. The lack thereof constitutes an administrative offense as defined by Chapter 1, Article 18.08 of the Code of the Russian Federation on Administrative Offenses, i.e., “violation of the procedure of entering the Russian Federation.”

**When entering the Russian Federation, foreign citizens must have medical insurance on them;** in case they do not have any, they must immediately apply for one at Krasnodar insurance companies.

Foreign citizens are eligible for obligatory health insurance (henceforth “OHI”) if they have obtained either a temporary residence permit, a temporary residence permit for education, or permanent residency.

Thus, in pursuance of the legislation of the Russian Federation, a foreign student is obliged to provide a copy of a valid VHI (OHI) policy in a timely manner to the Migration Assistance Department, which ensures the provision of emergency care, urgent hospitalisation, repatriation to the doorstep, passing medical examinations in accordance with the legislation of the Russian Federation, including preventive medical examinations in connection with physical culture and sports.

## RESIDENCY IN THE RUSSIAN FEDERATION IN CASE OF EXPLUSION FROM UNIVERSITY OR ACADEMIC LEAVE

Foreign citizens who have prematurely terminated their studies (**expelled**) or completed their studies (**graduates**) on a full-time or part-time basis, in accordance with paragraph 1 of Article 31 of the Federal Law “On the Legal Status of Foreign Citizens in the Russian Federation” of 25.07.2002 No. 115-FZ (ed. 14.07.2022) **must leave the Russian Federation within three days from the date of issuance of the order of expulsion.**

Foreign citizens studying on a full-time or part-time basis, who are granted **academic leave** in accordance with paragraph 1 of Article 31 of the Federal Law “On the Legal Status of Foreign Citizens in the Russian Federation” of 25.07.2002 No. 115-FZ (ed. 14.07.2022) **must leave the Russian Federation before the expiry of the visa.**

In accordance with paragraph 3 of Article 31 of the Federal Law “On the Legal Status of Foreign Citizens in the Russian Federation” of 25.07.2002 No. 115-FZ (ed. 14.07.2022), a foreign citizen who has not fulfilled the obligation to leave the territory of the Russian Federation **is subject to deportation.**

## DORMITORY ACCOMMODATION

Foreign students live in 20 five-storey well-appointed dormitories with access to free wireless Internet. Sectional blocks of dormitories are equipped with shower rooms, kitchens, laundry rooms with washing machines and reading rooms.

Before moving into the dormitory, foreign students are obliged to obtain a **medical admission** at the student clinic upon presentation of medical certificates, as well as a **migration registration admission** issued by the Migration Assistance Department.

When moving in, foreign students are obliged to familiarise themselves with the Rules of living in student dormitories of Kuban SAU and undergo a safety brief.

**COST OF ACCOMMODATION** for full-time students is **1740,00 RUB** per month (*Rector's Order "On Establishment of Fees for Accommodation in dormitories of State Federal-Funded Educational Institution of Higher Professional Training Kuban GAU from 01.09.2024 for the 2024-2025 academic year"*).

## SCHOLARSHIP

State-funded students (on federal funding) are eligible for merit-based state academic scholarships; the bachelor's, specialist, and master's program students who successfully pass all the exams during the examination period are paid:

- 2,071 RUB (exclusively “Good” students);
- 2,589 RUB (students graded both “Good” and “Excellent”);
- 3,106 RUB (exclusively “Excellent” students);

## EXTRA EXPENSES

- Voluntary medical insurance ≈ **9,000 RUB**; the cost depends on the medical services covered.
- Medical clearance expenses ≈ **11,000 RUB**.
- Authentication of the education certificate (if needed) ≈ **12,000 RUB – 15,000 RUB**.
- Translation of documents and notary costs ≈ **5,000 RUB**.
- Krasnodar public transport fare (buses, trolleybuses, trams) – **55 RUB**.
- A full-course meal at the university canteen ≈ **400 RUB**.
- According to students, monthly expenses in Krasnodar on meals, transport, mobile services, etc. can reach up to ≈ **25,000 RUB – 30,000 RUB**.
